

ACCOUNT OPENING REGISTRATION GUIDE

PEMBUKAAN AKAUN PANDUAN PENDAFTARAN

- 1. Download M+ Global App Muat turun Aplikasi M+ Global
 - Download the app from AppStore (iPhone) / Google Play (Android) / AppGallery (Huawei).
 Muat turun aplikasi di AppStore (iPhone) / Google Play (Android) / AppGallery (Huawei).
 - After download, click on the app logo and launch the app. Setelah muat turun, klik pada logo aplikasi dan lancarkan aplikasi.







2. Open Account *Pembukaan Akaun*

 Once the app is launch. At the bottom, click "Account" and click "Get Started".
 Sebaik sahaja aplikasi dilancarkan. Di bahagian bawah, klik "Account" dan klik "Get Started".









- 4. Enter Verification Code Masukkan Kod Pengesahan
 - You will receive a 6 digit Verification Code (OTP) in your SMS.
 Anda akan menerima 6 digit Kod Pengesahan (OTP) dalam SMS anda.
 - Key in the 6-digit code.
 Masukkan 6 digit Kod tersebut.





5. Create New Password Cipta Kata Laluan Baharu

✓ Key in your preferred password.

Kindly ensure that it is a minimum of 8 characters, with a combination of alphabets, numbers and special characters. (Example: Global123!)

 - New client TICK for MY Market (Bursa + CDS).
 Existing client M+ UNTICK for MY Market.

 Klien M+ TIDAK PERLU TANDA pada MY Market (Bursa + CDS).
 - You may choose Cash Upfront Account or Islamic Cash Account only.

Cash Account – Conventional Account (can trade all counters) Islamic Cash Account – Shariah Account (can trade for shariah counters only)





7. Market & Account Type Pasaran & Jenis Akaun

Tick the both Global Market to open.

✓ TURN OFF the Share Margin Financing Account.

If you wish to open the Share Margin Financing Account, you can convert the account later. However, the Share Margin Financing Account **CANNOT** be converted to the Cash Account. Please contact your Dealer's Representative / Remisier for advise.
